

ADDENDUM NO. 01

Dated April 10, 2025

1. GENERAL

This document includes requirements that clarify or supersede portions of the bid and/or contract requirements for the project. This Addendum is a Contract Document.

2. SUMMARY

The following changes, additions and deletions shall be made to the following document(s) as noted in **RED**; all other conditions shall remain the same.

Q&A

1. Question: Is there a bid form? No form included in issued bid documents.

Answer: Attached Document 00 41 13 Bid Form and Proposal Document included with Addendum No. 01

2. Question: Is bonding required? No bid bond or bonding requested in bid documents.

Answer: Attached Document 00 43 13 Bid Bond included with Addendum No. 01

3. Question: The Prestige Velour in the specified color requires 4 weeks to get the fabric, 2 weeks to fabricate with 1 week of combined transit time, 7 weeks total from release. When is the release of the stage draperies expected after the award of contract?

Answer: Upon receipt of Document 00 55 00 Notice to Proceed, vendor must submit preliminary schedule of submittals; including Shop Drawings, Product Data, Samples, and Warranty & Maintenance Document submittals for District review/approval by 5:00PM of the tenth (10th) calendar day following the date of the Notice to Proceed. Release of materials must be after submittal approvals.

4. Question: The RFP states: "vendor to aim and focus all new light fixtures to production stage area." To do this we require additional information:

- a. What is the intended function for each fixture? Please provide.

Answer: The ColorSource CYC is a dedicated cyclorama fixture designed with the sole purpose of creating beautiful, smooth washes of light on a cyclorama or wall. The Source Four LED Series 2 revolutionizes LED lighting with optimized arrays and finely-tuned electronics & offers a combination of light quality and output that cannot be matched. Source Four LED Series 2 Lustr luminaires are based on the x7 Color System, utilizing seven colors including high-output lime to achieve true, usable broad-spectrum color with a depth and feel beyond any RGB fixture. Series 2

light engines work with all Source Four lens tubes to deliver a high-quality, controllable beam of LED light. ColorSource PAR offers a quality of build and light that has never been seen in an affordable wash fixture. Using ETC's RGB-L color system, the ColorSource PAR provides a rich, bright light unlike any other LED wash light in its class. ColorSource Deep Blue replaces those blue LEDs with a deeper 'Royal Blue' (indigo) LED. Element 2 control console provides the powerful features of the Eos system in an economical and simplified package.

b. What are the focus areas of the front lights? Please provide.

Answer: District AV will not be adding the focus areas to the Lighting Plot Plan. Vendor to decide on the focus areas per industry standard/experience.

c. What are the focus areas for the back lights? Please provide.

Answer: District AV will not be adding the focus areas to the Lighting Plot Plan. Vendor to decide on the focus areas per industry standard/experience.

d. What are the instrument numbers, DMX addresses and channels? Please provide.

e. Please provide a Symbol Key for the light plot with item d information.

Answer: Lighting Plot Plan included with RFP included instrument numbers for each equipment. Said instrument numbers align with newly included EOS Show File Printout document.

5. Question: Will we be able, after receipt of a contract, to order, store, and bill for stored equipment to guarantee we will have the equipment to meet the installation deadline?

Answer: District will not release payment for equipment until delivery, assembly, hanging, and final sign off confirming all scope for each equipment is provided by CM to District. Per Section III. Scope of Services, vendor must provide deliveries to the site within 72 hours upon District/CM request.

extension of time, alteration or addition to the terms of the Contract or the call for bids, or
to the work, or to the specifications.

In the event suit is brought upon this bond by the Obligee and judgment is recovered, the Surety shall pay all costs incurred by the Obligee in such suit, including a reasonable attorneys' fee to be fixed by the Court.

If the District awards the bid, the security of unsuccessful bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.
